

BAD CHECK POLICY

The policy as reported in the May issue of the REALTORS® REVIEW was in error concerning the third time a member remits a check or checks for services rendered which are returned from the bank marked "insufficient funds."

There will be a charge of \$15.00 per check for a "first offense" in which the first check in any calendar year is returned. On the "second offense" a \$30.00 per check fee will be charged to the offender. Following the second offense and thereafter, the member will be required to remit the funds in cash or a cashier's check for the remainder of that calendar year. This action became effective on June 1, 1981.
