
Dear Ms. Davidson:

This letter is written on behalf of Rob Kolar, Realtor, as part of the confirmation for his requirements to be designated as a **Realtor Emeritus**. I have known Rob for almost 40 years – he as a practicing Realtor in Union and Middlesex Counties, and I as a real estate attorney representing buyers and sellers of residential and commercial properties, as well as representing clients in land use matters until my retirement four years ago.

I retired from the active practice of law after almost 53 years, having opened my office and started my law firm in Clark in September 1965. During 20+ years of my practice I served as the attorney for the Rahway Board of Realtors, then the Eastern Union County Board of Realtors, and the Union County Board of Realtors. Throughout that tenure I got to know Rob and work closely with him as he assumed leadership positions in the Board [a] as a newly licensed Salesperson in 1981, [b] while working with his father in their office until 1983, [c] when he became a licensed Broker in 1983, [d] his involvement in the Eastern Union County Board of Realtors, then later the Greater Union County Association of Realtors where he rose through the chairs of leadership from being a Director in 1984, Treasurer in 1985, Secretary in 1986, Vice-President in 1987-'88, and President in 1989-'90.

He also served as Vice President and Founding Member of the Garden State MLS in 1990. His involvement in the NJAR included serving on and chairing various Committees, then also as a Director of the NAR from 1988-'92. As the Board attorney and practicing in the area of law wherein he and I often crossed paths either in the same transaction or otherwise, I always found his work on behalf of his clients as well as among his colleagues to be exemplary, well-prepared, fair, ethical, and thorough.
