### **Criteria for Nominations**

#### Applicants for award must:

#### **REQUIRED**

- Be a member in good standing with the National Association of REALTORS®
- Must be an International REALTOR® for a minimum of 2 years
- Promotes the National Association of REALTORS® and the REALTOR® brand outside the U.S.

(Examples include REALTOR® logo/branding on website, business cards, other marketing materials; helped to bring NAR education/resources to home country/association: active in the Ambassador Association Program, hosted or participated in REALTOR® trade missions, etc.)

- Attend the REALTORS® Conference & Expo in past years
- Volunteers time/resources to NAR and/or home association
- Shows commitment to the REALTOR® Code of Ethics

#### **ENCOURAGED**

 Encouraged, but not required to have completed an NAR or NAR affiliate designation or certification program(s) - CIPS, ABR, SRES, GREEN, RSPS, IREM, SIOR, etc.

## Recognition

The winner of the 2017 International REALTOR® of the Year will receive:

- Two FREE tickets to International Night Out at the 2017 REALTORS® Conference & Expo in Chicago, where winner will be recognized on stage
- Recognition in NAR Global publications, social media and website
