



Commemorating the 50th Anniversary of the Fair Housing Act

Missouri REALTORS® will be accepting applications between April 25 and July 31, 2018, from local Boards/Associations requesting grant funds for activities that promote fair housing in our communities. We are calling this the “\$50,000 in the 50th Year” Grant Program.

Our goal is to be flexible and encourage creativity. Therefore, grants can be requested in any amount up to \$5,000 for any purpose as long as the activity promotes cultural diversity and the ideals of fair housing. Ideas of possible activities include:

- Activity commemorating the 50th Anniversary of the Fair Housing Act
- Participation in a local Community’s HUD required Fair Housing Assessment process.
- Grants to address local fair housing issues with local fair housing organizations or government fair housing agencies.
- Activities or programs that are designed to expand the inclusion of diversity in the leadership fabric of the local board/association.
- Partnering with a local chapter of the National Association of Real Estate Brokers, the National Association of Hispanic Real Estate Professionals or the Asian Real Estate Association of America.
- Compensating an instructor for the [Leading with Diversity Workshop](#)
- Embracing our role in advancing fair housing and leading efforts to address community fair housing issues.
- Activities that seek to enhance the diversity of our membership and board/association leadership.
