Т	F	1.	The Code of Ethics is based on the "caveat emptor" concept.
Т	F	2.	REALTORS <sup>®</sup> have an obligation to protect and promote the interests of their clients regardless of the effect on any other party or REALTOR <sup>®</sup> .
Т	F	3.	At the time the Code of Ethics was adopted, there were no real estate licensing laws.
Т	F	4.	The Code of Ethics was adopted to establish standards of conduct in the industry.

Т	F	10.	Only members of the public may file a complaint against a REALTOR® alleging a violation of the Code of Ethics.
Т	F	11.	Arbitration hearings are often based on a procuring cause dispute between REALTORS <sup>®</sup> associated with different firms.
Т	F	12.	The Code requires that REALTORS <sup>®</sup> respect the agency relationships that other REALTORS <sup>®</sup> have with their clients.
Т	F	13.	The Code of Ethics prohibits exaggeration, misrepresentation and concealment of pertinent facts about the property or the transaction.



Т	F	14.	Generally, a licensee can rely on the statements given by the seller (such as in a Seller Disclosure Statement) unless the licensee has reason to believe that the information which the seller has given is not true.
Т	F	15.	The requirement to secure agreements in writing extends only to sale contracts and not to changes or amendments to the contract.
Т	F	16.	A listing licensee must be particularly careful not to say anything about the property or the price of the property which might harm the owner's interests.
