The beginnings of the Multiple Listing Service (MLS) can be traced back to the San Diego Real Estate Exchange in 1887, then followed by the Cincinnati and Cleveland Exchanges in 1892. William A. Keadin said that he organized the first system in 1907 and coined the term "multiple listing service." He wanted to "establish more friendly and honorable methods in the business between brokers by interchanging their listings through a central bureau, or clearinghouse, thereby creating more confidence between owners, agents, as well as courts and assuring owners under exclusive contracts the concerted action of the members of the bureau." The early establishment of exclusive contracts was the backbone of the formal MLS system. By the early 1920s, NAREB established a Multiple Listing Committee under the Secretaries Council and was beginning to produce manuals and handbooks to encourage local boards to operate MLSs.

In 1956, the Association appointed an official Committee on Multiple Listing Policy. The Committee conducted surveys, created uniform policies for local board MLSs, and in 1965 authored the first Handbook on Multiple Listing Policy. The Handbook served as the official guide to "ensure that MLSs owned by or affiliated with REALTOR® boards functioned in a manner consistent with the best interests of REALTORS®, their clients, and the public." The MLS allowed for an orderly sharing of listings between REALTORS® and created a marketplace with consistent rules and regulations. As the age of the Internet dawned, the MLS moved online and policies about data exchange and virtual listings were developed to keep the marketplace fair and consistent for all MLS users.

The MLS continues to be a foundational part of REALTORS®' businesses and this series captures the history, the evolution, and the modern operation of the Multiple Listing Service's







cooperative efforts. The material in this series includes the beginnings of the MLS; the MLS Committee in its early and modern forms; the legal cases associated with commissions, anti-competition, and internet data exchange; the efforts of local associations to establish, promote, and operate MLSs; and the formation of an ever evolving Handbook on Multiple Listing Policy.

## **B12:04 Multiple Listing Committee**

Throughout the early years of NAREB, there were several attempts to assist member boards in multiple listing activities. In 1956 these activities were formalized and the Committee on Multiple Listing was established. The Committee worked to create a Handbook on Multiple Listing Policy, to fight legal battles against MLS tax exemption, and to develop and make recommendations uphold the rules and regulations for all participants. Today, the Committee serves much the same purpose, to develop and recommend rules and regulations, and to make those available to all MLSs, whether operated by member boards or independently operated.

## **B12:05 Multiple Listing Legal Cases**

The MLS has faced legal challenges throughout its history. One of the most challenged aspects of the MLS was the question of whether agents had to be a member of the local board of REALTORS® to join and have access to the MLS. Ultimately the decision was made to allow local board MLSs the option to give non-members access to the MLS in order to dispel anticompetition and anti-trust legal questions. There have also been legal questions related to the tax exemption of MLSs, commission rates, and the exchange of internet data as listings became readily available online. The cases here discuss taxation and anti-trust/anti-competition, as well as NAR's case with the Department of Justice on Virtual Office Websites (VOWs). The full VOW policy can be found in B12:02.
