

## **COMPLIANCE REPORTING PROCESSS**

- State Associations will adopt their own protocol for compliance audits as appropriate
- Failure to comply with any of these Core Standards will result in mandatory referral to NAR for appropriate action up to and including revocation of Association charters
- To the extent feasible, required proof of compliance should be provided electronically
- Unless stated otherwise, the timeline for each Core Standard requires annual performance and compliance
