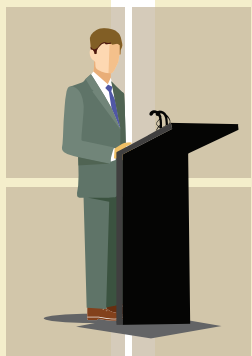

Investor community can choose to invest in issue or candidate campaigns or both.

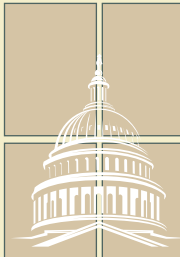

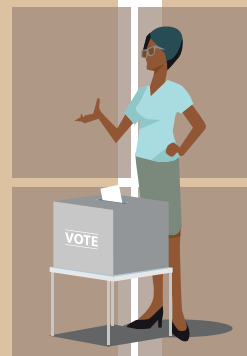

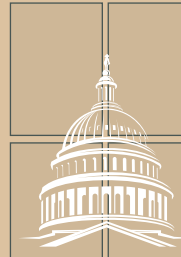
